

I declare I have familiarised myself with the *Terms and Procedure of Recruiting Candidates to the First Doctoral School* as adopted in the resolution of the *Senate of the Medical University of Gdańsk* and with its *Regulations* published at the following address: <https://doktoranci.gumed.edu.pl/56505.html>.

I declare I have been informed of the content of section 209(10) of the Higher Education and Science Law Act of 20 July 2018 (Journal of Laws it. 1668, as amended) and its impact on the process of recruitment to the Doctoral School (section 209(10) of the Higher Education and Science Law Act of 20 July 2018: *The doctoral student cannot be employed as an academic teacher or researcher. The ban does not extend to employing the doctoral student: 1) for the purpose of pursuing a research project referred to in section 119(2)(2) and 119(2)(3); 2) after positive mid-term assessment, provided that if the employment contract is signed for more than half a full job time, the amount of the scholarship shall be 40% of the monthly scholarship referred to in subsection 4(2); 3) who is not eligible for doctoral scholarship.*)

I acknowledge and accept the information given below, ensuing from the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter: the GDPR):

3. Your personal data shall be processed to carry out the recruitment to the MUG Doctoral School based on Art. 6(1)(a) GDPR – i.e. the consent given, and if you are a candidate with a disability or chronic disease – based on Art. 9(2)(a) GDPR, i.e. your explicit consent to the processing of your health data. If the candidate is admitted to the Doctoral School, his/her data shall be processed for the purpose of implementing the educational process, documenting its progress, and for the Administrator's compliance with his statistical, statutory, and archiving obligations stemming from the Higher Education and Science Law Act of 30/08/2018 (JoL 2018: it.1668) and the Regulations of the MUG Doctoral School – based on Art. 6(1)(c) and (e) GDPR – i.e. to comply with the legal obligation resting with the Administrator and if the processing proves necessary to complete a task pursued in public interest.
4. Your personal data may also be processed for the purpose of:
 - a) your using the library resources, and for the Main Library of the Medical University of Gdańsk to perform its tasks with respect to serving the user via access to the common, partnership library and information system of the Tri-City Library Complex (Academy of Music in Gdańsk, Maritime University in Gdynia, Academy of Fine Arts in Gdańsk, Academy of Physical Education and Sport in Gdańsk, and the European Solidarity Centre in Gdańsk) based on GDPR Art. 6(1)(a), i.e. your given consent to the processing of your personal data,
 - b) determining and seeking potential claims in the situations prescribed in the regulations of the common law,
 - c) familiarising you with the organised events, courses, conferences, competitions, promotions, and questionnaires based on GDPR Art. 6(1)(a), i.e. your given consent to the processing of your personal data,
 - d) holding the visual monitoring based on GDPR Art. 6(1)(f), i.e. in pursuance by the Medical University of Gdańsk of its legitimate interest,
 - e) complying with the legal obligation which ensues from the Regulation of the Minister of Health, dated 26 August 2014, on medical examinations of candidates to senior higher schools and colleges and to vocational qualification courses, and of students of the schools and colleges, and participants in vocational qualification courses and doctoral students (Journal of Laws 2014: it. 1144, as amended) based on GDPR Art. 6(1)(c) and GDPR Art. 9(2)(h).
4. Your provision of your personal data once you have decided to join in the recruitment is indispensable for the attainment of the objectives specified in items 3 and 4. In addition, it is prerequisite for your participation in the recruitment and for documenting the course of your studies at the Doctoral School.

5. The recipients of your personal data shall be: the entities entitled to obtain the data under the letter of the law, and the persons the Data Controller may authorise to process them in performance of their professional duties. The recipients of your data may also include the entities the Data Controller might commission to provide services, especially the service of processing the course of studies at MUG, as well as other entities under data processing agreements.
6. Your personal data shall be processed for recruitment purposes over the time it takes to complete all actions connected with the process, and for archiving the documentation in accordance with the regulations binding at the University, and in the event you are admitted to the MUG Doctoral School for the duration of your studies, whereupon they will be stored for archiving purposes for the period of 50 years. If you are entered in the list of doctoral students, your data used for recruitment shall be transferred to the University's IT systems, particularly to the 'VERBIS' system serving students and doctoral students.
7. Pursuant to the rules laid down in the GDPR, you have the right to:
 - a. access your personal data,
 - b. rectify them, if discordant with the facts,
 - c. delete them, restrict their processing, and transfer them in the cases prescribed in the law,
 - d. object to the processing of the data,
 - e. lodge a complaint with the supervisory body, i.e. the President of the Personal Data Protection Office, if you come to believe that the processing of your personal data infringes on the personal data protection regulations.
8. The data you provide shall not be processed automatically or subject to profiling.
9. The Data Controller has no intention to transfer personal data to any third country of an international organisation.
